

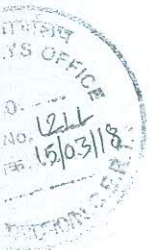

Sir/Madam,

Rashtriya Mahila Kosh, a Society registered under the Societies Registration Act, 1860, set up under the Ministry of Women and Child Development, Government of India, has been providing micro finance to poor women through its partner NGOs since 1993.

For ensuring sustainability of operations of RMK and to provide credit facilities to more and more beneficiaries it is essential that loan is repaid by NGO as per mutually agreed schedule. However, the NGO commit series of defaults in payment of due installments and do not respond favourably inspite of concerted efforts. RMK has to perforce blacklist such organizations. Any NGO paying up the overdue is delisted from the blacklisted organizations.
