## Terms & Conditions:-

1. Condemned/Obsolete material, vehicles and old trees will be sold out on '**As is where is basis**' to the highest bidder.
2. The sale/bid value shall be deposited by the highest bidder on the same day in cash.
3. The interested bidders will have to enclose the DD/BC to tune of Rs.15,000/- for vehicles, Rs.15,000/- for condemned material and Rs. 5,000/- for old trees, in favour of Secretary, NCERT as refundable to the unsuccessful bidder.
4. The bid will be increased @ Rs.5,000/- per step in respect of condemned material and vehicles and the bid will be increased @ Rs.2,000/- per step in respect of old trees.
5. The condemned materials, vehicles and old trees can be inspected from 29/05/2017 to 02.06.2017 between 10.00 a.m. to 4.00 p.m. in the premises of NCERT.
6. The possession of condemned material will be given to highest bidder on the full payment of bid value after completing all the formalities
7. The highest bidder/purchaser will have to remove the condemned material within Three days at their own cost. Thereafter, an amount of Rs.2,000/- per day will be charged as ground rent.
8. In case, if the highest bidder does not lift the condemned material and vehicles within three days than the ground rent, the bid security/EMD of Rs.15,000/- for vehicles/condemned material and Rs. 5,000/- for old trees deposited by him shall be forfeited and liable for taking action against him i.e for re-sale of the condemned material at the risk and cost of the depositor.
9. The highest bidder will have to deposit 12.5% VAT on the entire bid amount with the concerned authority and the deposit slip shall be submitted in the NCERT.
10. In case of any dispute arises relating to any aspects of this contract between two parties, the decision of the NCERT shall be final.
11. In case the date of auction is declared holiday on any account, the auction will be taken place on the next working days.
