## 1. INVITATION FOR BIDS

1.1 National Council of Educational Research and Training (NCERT), Sri Aurobindo Marg, New Delhi - 110016 invites online Short Limited tenders from reputed Catering Contractors having minimum **three years experience** in the field of providing outdoor catering for large gatherings organized by any Govt. Departments/PSU/Autonomous bodies etc. including gathering of students in camp formations and with minimum **Annual Turnover of Rs.25 lakhs** per year for last three financial years, for catering service contract in respect of the National Yoga Olympiad - 2018 to be held at NCERT Campus, Sri Aurobindo Marg, New Delhi from 18th June, 2018 to 20<sup>th</sup> June, 2018

1.2 The bidders are required to accept all terms & conditions mentioned in the Tender Document without any pre-condition. NCERT has not bound to accept the lowest offer. However, final offer will be issued only to those caterer whose rates are reasonable, to provide quality & hygienic food, as per the recommendations of the committee after inspection of caterer premises. The NCERT also reserve the right to reject any or all offers without assigning any reason therefore.

1.3 It is the responsibility of the bidders to read all terms & conditions of the Tender Document before filing the tender form. Incomplete Tender Documents or bids are liable to be rejected. Tenders received after the due date and time will not be entertained.

## 2. EARNEST MONEY DEPOSIT.

2.1 Bid must be accompanied by a Bank draft/ Banker's Cheque of a Nationalized/ Scheduled Bank for **Rs.75,000/- (Rupees Seventy five thousand only)** drawn in favour of **Secretary, NCERT, payable at New Delhi** as Earnest Money, which will be refundable in due course to the unsuccessful bidders without any interest. **PLEASE NOTE THAT OFFERS NOT ACCOMPANIED BY THE REQUIRED EMD WILL BE DEEMED REJECTED.**

2.2 Offers submitted with incomplete information will not be considered.

2.3 The Earnest Money Deposit of the successful bidder is liable to be forfeited if the bidder does not fulfill the following terms and conditions:-

- i) If the bidder withdraw his bid during the tendering process.

ii) The successful bidder shall **commence the catering service at National Olympiad – 2018, NCERT Campus, Sri Aurobindo Marg, New Delhi from breakfast hour on the morning of 17<sup>th</sup> June 2018 and continue the service without break till the closure of the camp on 21<sup>st</sup> June, 2018.**

ii) Successful bidder has to deposit Performance Security Deposit, as stipulated under Para 7 below, within the stipulated period, which will be valid for a period of **sixty days** beyond the date of completion of all contractual obligation, if any. Thereafter, the security deposit of the successful bidder will be refunded after completion of the above contractual obligations, without any interest thereon.

### **3. SCHEDULES OF TENDER**

3.1 The Tender Document can either be downloaded from the website of NCERT i.e [www.ncert.nic.in](http://www.ncert.nic.in) or from CPPP portal i.e <https://eprocure.gov.in/eprocure/app>. All the scanned copy of documents required in the technical bid along with EMD & Tender cost will be uploaded on CPP portal before last date and time. However, hard copy of EMD and tender cost will be deposited in S&S Section before last date and time. **Offline tender will not be considered at any cost.**

3.3 The Technical & Financial bids shall be uploaded on CPP portal before last date and time i.e 12.06.2018 by 1.00 p.m. No bids will be accepted after the last date & time at any cost. The technical bids will be opened on 13.06.2018 at 2.00 p.m in the chamber of Sr. Stores Officer, S&S Section, Workshop building, NCERT, Sri Aurobindo Marg, New Delhi.

3.3 The Financial Bids of only those bidders will be opened whose Technical bids are accepted by the Competent Authority. The date time and venue for opening of Financial Bids shall be communicated to the technically qualified bidders at a later date. However, while opening the financial bids, NCERT reserves the right to not invite those bidders whose technical bids are declared as 'not qualified'.

3.4 Any tender received after the date and time given above will not be entertained under any circumstances.

3.5 The competent authority reserves the right to reject any or all tenders without assigning any reason and shall not bind it-self to accept any tender and reserves the right to call for fresh tenders.

#### **4. PROCEDURE FOR SUBMISSION OF BIDS.**

1. The bidder are requested to upload all the scanned copy of documents required in technical bid along with scanned copy of DD/BC of Rs.1,000/- of tender cost and DD/BC of Rs.75,000/- of EMD in favour of Secretary NCERT payable at New Delhi will be uploaded on CPP portal before last date and time i.e 12.06.2018 up to 1.00 p.m. However hard copy of EMD and tender cost must be submitted in S&S Section before last date and time. Tender will be accepted in online mode only. Offline tender will not be considered at any cost.

#### **5. BIDDERS' QUALIFICATIONS.**

5.1 The bidder should have a **minimum of three years experience** in outdoor catering for large gatherings including public functions organized by Government Departments/PSU/Autonomous body etc. and gatherings of students in camp formations running for a continuous period of at least a week;

5.2 The catering arrangement is to be set up at the NCERT Campus all meals would be prepared in the kitchens established within the NCERT Campus premises; and meals would be served to the participant in the messing halls adjacent to the kitchens and an appropriate place as decided by the Chairperson, NIE, Guest House, NCERT. The prospective bidders would be allowed requisite opportunity of inspecting the kitchens and messing halls. Preference would be given to bidders having previous experience of working in similar environment.

5.3 The minimum annual turnover of the bidder should **be Rs. 25 lakhs per annum during the last three preceding years i.e. 2014-15, 2015-2016 and 2016-17.**

5.4 The bidder should possess valid service tax registration, GST/TIN, PAN for income tax purposes. The bidder shall furnish details of registration of the firm with other Govt. Departments and shall also furnish an affidavit of non-blacklisting of the firm, if any, by any Government Department, in the prescribed format included in the tender document.

5.5 The bidder shall declare that only professional cooks certified as having at least five years' experience of cooking vegetarian meals for such large gatherings shall be deployed. It will also be declared that at least one person having professional degree/diploma in 'Catering' from a recognized institution shall be present at the Camp at all meals for supervision of catering operations.

## **6. SCOPE OF WORK**

6.1 The contract is for providing catering service including preparing and serving meals, beverages and packed day meals, at National Yoga Olympiad - 2018, National Council of Educational Research and Training, Sri Aurobindo Marg, New Delhi - 110016 from 17<sup>th</sup> June, 2018 to 21<sup>st</sup> June, 2018 to the participant school children from all over the country, organizers and operational staff deployed in the National Yoga Olympiad - 2018.

**6.2 The number of participant including school children Jury Members, Guests, Organizers, Students and operational staff is about 700 (approx.).** The number of actual arrivals is, however, liable to vary. The catering service and the consequent billing will be only in respect of actual arrivals/ attendance. For this purpose, the caterer will distribute food coupons to the arriving participants on their entry in the National Yoga Olympiad - 2018 and the billing will be on the basis of number of coupons actually consumed.

6.3 The catering service will comprise three meals viz. breakfast, lunch and dinner with tea/ coffee in forenoon and afternoon. However the bidders are requested to go through the menu as mentioned in the tender document. Water bottles with dispensers will also be provided by the caterer in the messing halls and in all the barracks where the participants would be accommodated. Bottled water would also be provided on demand.

6.5 A city tour would be organized for the participants on 18<sup>th</sup> or 19<sup>th</sup> June, 2018 for which a packed day meal with bottled water would be provided by the caterer.

6.6 The caterer would bring his own cooking implements, utensils, fuel, crockery and cutlery. The facilities available at the kitchens in the NCERT Campus including supply of filtered/ treated water for cooking/ drinking purpose, would be utilized in consultation with and in compliance with instructions of the Chairperson, NIE, Guest House, NCERT. Arrangements

for washing of utensils and dishes including crockery/ cutlery would be made by the caterer.

6.7 All the raw material and consumables to be used for cooking the meals would be brought by the caterer and all such material would conform to all food safety, hygiene and nutrition standards prescribed under the provisions of Food Safety and Standards Act, 2006 and the rules/regulations framed there under by the Food Safety and Standards Authority of India (FSSAI).

6.8 Further, the caterer would ensure that all the food material used in cooking conforms to the standards laid down in the rules/regulations framed by the FSSAI in with respect to additives, contaminants, toxins, residues, packaging etc. As far as practicable, all consumables, specifically milk and milk products, oils/ ghee/ fats, cereals/ pulses/ flour, spices, condiments shall be sourced from Govt. outlets, viz. Kendriya Bhandar, Safal etc and brought and stored in packaged condition to prevent any deterioration in quality standards.

**6.9 The duration of yoga programme is to be held from 18<sup>th</sup> to 20<sup>th</sup> June, 2018. However the successful caterer should be ready to make necessary arrangement of catering service one day prior to the programme and one day after of the completion of the programme i.e 17<sup>th</sup> June to 21<sup>st</sup> June 2018 if required as per the requirement.**

## **7. TERMS AND CONDITIONS OF CONTRACT**

7.1 The bids must be accompanied with a Bank Draft/ Pay Order issued by any Nationalized/ Scheduled Bank for Rs.75,000/- (Rupees Seventy five thousand only) only in favour of Secretary, NCERT, New Delhi.

7.2 The Technical Bids shall be opened in the room of Sr. Store Officer, S&S Section, NCERT, Sri Aurobindo Marg, New Delhi-110016 by a duly constituted Committee in the presence of such Bidders or their authorized representatives as may desire to be present at the time of opening of bids.

7.3 It is the responsibility of Bidders to read all the terms & conditions of this document carefully before submitting the bid. Incomplete bid documents or bids not responsive enough to the terms and conditions are liable to be rejected. The bidder should sign the undertaking along

with the bid document that he has read the complete tender document and will abide by its terms & conditions.

7.4 The financial bids shall be opened in the room of Sr. Store Officer, S&S Section, NCERT, Sri Aurobindo Marg, New Delhi-110016 and shall be evaluated on the basis of acceptance of rate.

7.5 The bid shall contain no erasures or overwriting except as necessary to correct errors made by the Bidder, in which case such corrections shall be authenticated by the person or persons signing the bid.

7.6 Bid Documents are neither transferable nor cost of the bid documents is refundable under any circumstances.

7.7 If, even after award of contract, any information/facts submitted by the bidders are found misleading/incorrect/false etc., NCERT reserves the right to terminate the contract.

7.8 The successful bidder has to furnish interest free **Performance Security Deposit @ of 10% of the total value of the order** in the form of Account Payee Demand Draft from a Commercial Bank drawn in favour of "Secretary, NCERT, Sri Aurobindo Marg, New Delhi" payable at New Delhi **or** Fixed Deposit Receipt/Bank Guarantee. This has to be given within stipulated period as mentioned in the letter of award of contract. The Security Deposit will be valid for a period of sixty days beyond the date of completion of all contractual obligations. No interest will be paid on such deposits. It may be noted that the Performance Security shall stand forfeited in the event of the firm fails to comply with the terms and conditions of the contract and thereafter the contract shall be treated as cancelled.

7.9 The Earnest Money Deposit will be refunded to the unsuccessful bidders after finalization of tender, without any interest.

7.10 However, the Earnest Money of the successful bidder will be liable to be forfeited, if the bidder does not fulfill any of the following conditions:

(a) The successful bidder shall have to deposit Security deposit before award of supply order. The security so deposited with NCERT, Sri Aurobindo Marg, New Delhi - 110016, shall not carry any interest.



(b) To undertake the work from the specified date mentioned in the award letter.

7.11 The successful bidder will have to **execute the complete catering contract as per Items and Rates as given in the** price schedule/Financial Bid document as per **Annexure-IV** attached with this Tender Document.

7.12 The successful bidder will be responsible for **executing the complete catering contract at** his own cost as per the requirement, irrespective of time. In case of any fault, delay etc., 'risk purchase' will be made by the NCERT out of the Security Deposit of the said Contractor (this includes the difference between the tender rate and risk purchase plus incidental charges etc.).

7.13 In case of supply of contracted items/ services, if such articles/ services are found deficient in quantity or quality and not of standard quality or not supplied in time, a deduction **of 10% will be made from the bill as penalty** or as decided by the Secretary, National Council of Educational Research and Training, Sri Aurobindo Marg, New Delhi – 110016. Repeated faults/ delays may result in forfeiture of part or whole of Security Deposit and even termination of the contract.

7.14 The successful bidder will ensure compliance of all the relevant provisions of the prevailing Laws.

7.15 National Council of Educational Research and Training, Sri Aurobindo Marg, New Delhi-110016 reserves the right to visit the existing or the past customers of the bidder to ascertain the quality of work performed by the bidder and in case any negative report is received against the bidder, the bid may be rejected. Also in case any information provided by the bidder is found to be false, such bid may be rejected and part or whole of the security forfeited.

7.16 The successful bidder will submit the bill in duplicate to Secretary, NCERT, New Delhi for arranging the payment. Payment will, as far as possible, be made within 30 (thirty) days from the date of receipt of bill after deduction of tax as per rules through A/c Payee Cheque or to be transferred to his/ her account through electronic system.

7.17 The Earnest Money of the successful bidder will be refunded after depositing of the Security Money against the contract. However, the same will not carry any interest.

7.18 Conditional/Incomplete offers not conforming to tender document will be rejected.

7.19 The bidder shall submit the ITR for the last three years (2014-15, 2015-16 & 2016-17) of the Firm/ Proprietorship Firm. However, no individual ITR will be considered/ accepted in any case by the NCERT.

7.20 Service Tax Registration No. with certified copies of Returns for the last three years i.e. 2014-15, 2015-16 & 2016-17 shall be submitted along with the bid document.

7.21 No Advance payment will be made and any offer linked with advance payment is liable to be disqualified. However, part payment can be considered by the NCERT on request by the firm with the approval of the competent authority.

7.22 After being declared successful, if the bidder fails to execute the contract as per the terms stipulated in the tender, the EMD will be forfeited and the bidder will be blacklisted from participating in any future bid/tender.

7.23 The decision on acceptance of tender will lie with the competent authority of NCERT, New Delhi who do not bind themselves to accept the lowest quotations received, without assigning any reasons.

7.24 NCERT reserves the right at the time of award of contract to increase or decrease the quantity without any change in terms & conditions.

**7.25 The Inspection Team of NCERT will be entitled to carry out inspection of the bidder's facilities at the venue for which the firm will have to have to make all necessary arrangements as may be required by the inspection team.**

7.26 All ingredients/consumables used by the contractor shall conform to the prevailing food safety laws. Any violation of the laws in this regard would be liable to result in cancellation of contract, forfeiture of performance security deposit apart from any other penal action that such violation may entail.

7.27 The contractor shall certify the professional qualifications/ experience as also the character/antecedents of all personnel deployed by him at the venue. Any incident of unprofessional or untoward conduct leading to endangering public safety or the well

being of persons present at the venue, will invite penal action which may extend to cancellation of contract, forfeiture of performance security deposit apart from any other penal action that such violation may entail.

7.28 The contractor shall also be responsible for maintaining safety of operations at the kitchens and mess halls at the venue and for complying with the orders/ instructions issued in that regard from time to time by the NCERT. Failure to conform to the safety requirements and failure to comply with any orders/instructions in this regard shall be liable to result in penal action including cancellation of contract, forfeiture of performance security deposit apart from any other penal action that such violation may entail.

7.29 The contractor will be required to furnish a certificate **(as per annexure-VI)** at the time of submitting the tender to the effect of accepting the condition of allowing prior inspection of his facilities including stocks, by designated team of NCERT within 5 days from the date of issue of offer letter from NCERT and the expenditure towards the inspection will be borne by the contractor.

7.30 The rates finalized and approved by the Competent Authority of NCERT may remain valid for two years for availing similar services in future requirement of NCERT if, required. However, the final decision in this regard will fully rest with the discretion of Competent Authority of NCERT.

## **8. INSTRUCTIONS FOR BIDDERS**

8.1 It will be mandatory on the part of prospective bidders to submit offer for **supply of the contracted items** as per the requirement & rates approved for the same.

8.2 It is mandatory for the bidders to quote the rates separately for each and every items failing which the bid of the firm will not be considered and will be summarily rejected.

8.3 Each page of the offer shall be numbered and bear the signatures of the bidder at the bottom. All offers shall be either type written or printed neatly in indelible ink. Any corrections should be properly attested by tender signing authority.

## **9. Resolution of Disputes**

The Purchaser and the Supplier shall make every effort to resolve amicably by direct informal negotiation, any disagreement or dispute arising between them under or in connection with the contract. If, after thirty (30) days from the commencement of such informal negotiations, the Purchaser and the Supplier have been unable to resolve amicably a contract dispute, either party may require that the dispute be referred for resolution to the formal mechanism specified in tender document. The dispute resolution mechanism to be applied pursuant to Clause shall be as follows:

“A dispute or difference arising between the Purchaser and Supplier relating to any matter arising out of or connected with the contract, such dispute or difference shall be referred to the sole arbitration of an officer in the Ministry of Law, appointed to be the arbitrator by the Director, NCERT. The award of the Arbitrator shall be final and binding on the parties to the contract subject to the proviso that the Arbitrator shall give reasoned award. The Indian Conciliation and Arbitration Act, 1996, the rules there under and any statutory modifications or re-enactments thereof, shall apply to the proceedings. The venue of arbitration shall be the place from where the contract is issued.”

## **11. Undertaking to be signed by the bidders**
