### Terms & Condition:-

1. Condemned/Obsolete material/machines & condemned vehicles will be sold out **"As is where is basis"** to the highest bidder.
2. The sale/bid value shall be deposited by the highest bidder on the same day in cash.
3. **The interested bidders will have to enclose the DD/BC only to tune of Rs.2,50,000/- as Security/EMD in favour of Secretary, NCERT and payable at New Delhi. The EMD will not be accepted in cash, which will be refundable to the unsuccessful bidder except first highest bidder and second highest bidder.**
4. The bill will be increased @ Rs.50,000/- per step and not below this amount.
5. The entry will be allowed to those bidders in the Auction hall only after depositing the Security/EMD amount as stated in item no. 3 and no other person will be allowed.
6. The condemned/obsolete material/machines & condemned vehicles can be inspected on any working day between 10.00 a.m to 4.00 p.m in the premises of NCERT.
7. The possession of condemned/obsolete material/machines & condemned vehicles will be given to highest bidder on the receipt of full amount of bid value after completing all the formalities.
8. The highest bidder/purchaser will have to remove the condemned material within two days at their own cost. Thereafter, an amount of Rs.2000/- per day will be charged as ground rent.
9. **In case, if the highest bidder does not lift the condemned/obsolete material (machine & tools) and three condemned vehicles i.e (1. DL-3CQ-5172 Ambassador car, 2. DL-3CP-9348 Ambassador, 3. DL3CE-7205 Gypsy) on the same day or even within the extended period of two days the bid security/EMD of Rs.2,50,000/- deposited by him shall be forfeited and liable for taking action against him. Thereafter, the condemned/obsolete material (machine & tools) will be sold out to the second highest bidder.**
10. The highest bidder will have to deposit 12.5% VAT on the entire bid amount with the concerned authority and the deposit slip shall be submitted in the NCERT or VAT can also be deposited with NCERT.
