**MINUTES OF THE MEETING OF COMMITTEE CONSTITUTED FOR
OPENING OF TECHNICAL BIDS FOR PROVIDING SECURITY SERVICES
AT NCERT CAMPUS HELD ON 14.3.2018.**

The committee comprising of the following members was constituted by the Council for completing/finalising the e-tender for providing Security Services at NCERT Complex including Nasirpur campus, New Delhi for hiring 42 trained security guards and 01 supervisor for manning the security of campus:

2. The last date of submission of online bid closed on 20.2.2018 at 1700 hrs and technical bids were downloaded from CPP portal on 22.2.2018 at 1500 hrs in presence of all committee members. At the opening the technical bids on 22.2.2018 at 1500 hrs, the representatives of two firms namely Shri Dhanjay Kumar from SIS(04/09) & Shri Satish Yadav from G4S (03/09) were present during the opening bids process and duly signed the attendance sheet. After completion of downloading of e-tender 22.2.2018 at 1730 hrs, total 09 (Nine) bids were received from the bidders as mentioned below:

3. To evaluate the technical eligibility criteria of above bidders, the meeting of committee was held on 14.3.2018 at 1500 hrs. Shri Rajesh Kumar, Under Secretary (C&W) has not attended the meeting as he was on leave. Before, evaluation, the committee discussed and decided the following issues:

- (i) As per terms and conditions of tender, 05 bidders (01/09, 03/09, 04/09, 06/09 & 07/09) have deposited an amount of Rs. 2 Lakh in prescribed formate before the opening of technical bids i.e. On 20.2.2018 whereas 04 firms namely (02/09, 05/09, 08/09 & 09/09) have submitted NSIE (MSME) unit certificate for exemption of EMD as per GOI rules. The committee has decided that EMD amount in respect of above 04 bidders be exempted as it is as per Government of India rules.
- (ii) One EMD amount of Rs. 2 Lakh dated 16.2.2018 in the form of Bank Draft has been received on 20.2.2018 from M/s Bombay Intelligence Security (India) Ltd however, the bidder failed to upload the technical bid document on CPP portal within the last date of submission of technical bids on 20.2.2018 upto 1700 hrs. In this regard, the bidder M/s Bombay Intelligence Security (India) Pvt Ltd vide letter dated 26.2.2018 has requested to NCERT to extend the date of submission of tender. The committee gothrough the entire issue and decided that request of bidder is not feasible as sufficient time as per GFR, GOI (21days) was provided to all the bidders and it is not possible to extend the date. The committee also decided that EMD of Rs. 2 Lakh received from bidder M/s BIS (India) Ltd be returned after approval of minutes by competent authority.

4. After detailed scrutiny of technical bids received from the bidders, the committee decided that **following bidders have qualified in technical bid process** in terms of technical/infrastrutcal point of view as under:

- 1/9. M/s Om Security & cleaning services
3/9. M/s G4S Secure Solutions Pvt Ltd
4/9. M/s Security & Intelligience services India Ltd
5/9. M/s Rakshak Security Pvt Ltd

5. The following bids received from undermentioned bidders **are not qualified** in the evaluation process of technical bids for the reasons as mentioned against their names:

2/9. M/s Centurion Detectives India Pvt Ltd

The bidder is not fulfilling the security experience criteria in terms of tender document clause "B" (xiv) at page 4 of tender document, which reproduced as "The tenderer shall furnish the details regarding the total number of works/services, each costing equal or more than Rs. 3 Crore per annum completed during the last three financial years and requiring supply of at least 100 trained security manpower per day to **three clients** in Delhi/NCR". The committee is of the view that bidder is not eligible.

6/9. M/s Orion Security Solution Pvt Ltd

(M/s Orion Security Solution vide undertaking daed 15.2.2018 informed that **One FIR** is registered against the company by PGIMS for which **investigation is currently in progress**. However, contract at PGMIS is still in progress and running smoothly. M/s Orion Security did not provide the details/facts of FIR lodged against the company.

As per terms and conditions of ELIGIBILITY CRITERIA OF TECHNICAL BID PART 'B' para xxi (page 5 of tender document), it is clearly mentioned that "The Agency shall furnish details of any legal case/FIR or any issues, if any, pending in any court of law against them or the concerned authorities, especially with regard to any violation in the statutory laws viz EPF Act, 1952 ESI Act, Minimum Wages Act, 1948, Industrial Disputes Act, 1947, Contract Labour (Regulation and Abolition) Act, 1970, and Contract Labour (Regulation and Abolition) Rules, 1971, other Labour Laws, and Income Tax etc. The bids of such tenderers having any pending/ongoing/contemplated issues relating to EPF, ESI, Labour laws, Income Tax, etc. on concealment of any such information will be liable to be rejected straightaway without any notice. The decision of the competent authority of NCERT in this regard will be final.

In view of the above, the committee is of the view that the NCERT will not intertain any ongoing litigation against the bidder, hence bidder is not eligible.

7/9. M/s Sarvesh Security Services Pvt Ltd

(i) As per terms and conditions of ELIGIBILITY CRITERIA OF TECHNICAL BID PART 'B' para xxi (page 5 of tender document), M/s Sarvesh Security Services Pvt Ltd failed to furnish details of any legal case/FIR or any issues, if any, pending in any court of law against them or the concerned authorities, especially with regard to any violation in the statutory laws viz EPF Act, 1952 ESI Act, Minimum Wages Act, 1948, Industrial Disputes Act, 1947, Contract Labour (Regulation and Abolition) Act, 1970, and Contract Labour (Regulation and Abolition) Rules, 1971, other Labour Laws, and Income Tax etc.

(ii) During the evaluation of technical bid received from M/s Sarvesh Security Services Pvt Ltd, it is evident at page No. 69 of technical bid submitted by bidder that they have also quoted rates of Financial Bid alongwith Technical Bid in vilation of instructions given in the tender documents at Para "D" (page 7) wherein it is clearly mentioned that "If any price details are found in the technical bids, the offer will be summarilly rejected". In view of the above facts, the committee is of the view that bidder is not eligible.

8/9. M/s Sayo Security Services

(i) The bidder is not having sufficient experience in providing security services in terms of para "B" sub para (xiv) of tender document.

(ii) The bidder is not fulfilling the criteria of Annual Turnover of Rs. 3 crore in security field in terms of para "B" sub para (xiii) of tender document.

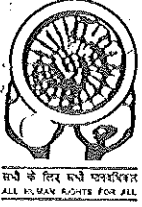

- (iii) As per terms and conditions of ELIGIBILITY CRITERIA OF TECHNICAL BID PARA 'B' sub para xxi (page 5 of tender document), M/s Sayo Security Services failed to furnish details/undertaking that any legal case/FIR or any issues, if any, pending in any court of law against them or the concerned authorities, especially with regard to any violation in the statutory laws. In view of the above facts, the committee is of the view that bidder is not eligible.

9/9. M/s Fireball Security & Consultants pvt Ltd.

- (i) The bidder is not fulfilling the manpower eligibility criteria as per tender document para "B" sub para (vi) (page 4) and para 6 of Technical Bid (Annexure-2) (page-26) of tender document as accepted by bidder.
- (ii) The bidder is not fulfilling the criteria of having wireless license issued by GOI (Para 18 of technical Bid) (page 28).
- (iii) The bidder is not having sufficient infrastructural capacity in terms of para 19(a) & (b) of Technical Bid.

In view of the above facts, the committee is of the view that bidder is not eligible.

Recommendation of committee

- (i) The committee recommends that minutes of committee meeting may be uploaded on the CPP portal as well as NCERT website for information to all concerned.
- (ii) The committee further recommends that financial/price bids in respect of following bidders who qualified in the technical bids may be opened on 26.3.2018 at 1500 hrs:
