1. Condemned material will be sold out on "As is where is basis" to the highest bidder.
2. The firms participated in the bid must have GST and PAN number of the firm.
3. The bidders will have to submit the original EMD amount of Rs.1.00 lakh in shape of DD/BC in favour of Secretary NCERT payable at New Delhi in S&S Section, Workshop building NCERT before last date of tender. The EMD amount of unsuccessful bidder will be returned to the bidder except first highest bidder, second highest.
4. The reserve price of all the condemned items has been fixed by NCERT is Rs.6.00 lakh (without GST) for all the items (consolidate). GST will be charged on actual as per the norms and GST amount will be deposited by the highest bidder to NCERT
5. The condemned/obsolete material can be inspected on any working day between 12.10.2022 to 23.10.2022 from 10.00 a.m to 4.00 p.m. in the premises of NCERT.
6. The bidders have to quote the consolidate price for all the condemned items lying in the junk yard of S&S Section. Items will be auctioned in single lot basis, no item will be sale individually.
7. After issuing of award letter to the highest bidder , the auction amount shall be deposited by the highest bidder in form of DD/BC in favour of Secretary NCERT payable at New Delhi within 03 days.
8. The possession of condemned/obsolete material will be given to the highest bidder on the receipt of full amount of bid value after completing all the formalities.
9. The highest bidder will have to remove the condemned/obsolete material within seven days at their own cost and risk.
10. In case if the highest bidder does not lift the condemned material within 03 days than a penalty of Rs.5,000/- per day on account of ground rent shall be charged from the successful bidder.
11. In case of any dispute arises relating to any aspects of this contract between two parties, the decision of NCERT shall be final.
